To achieve consistent capital appreciation over medium to long-term by investing mainly in listed Malaysian companies with good growth prospects.

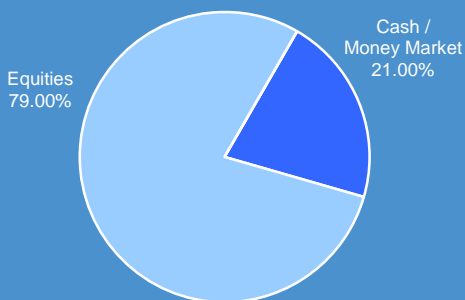

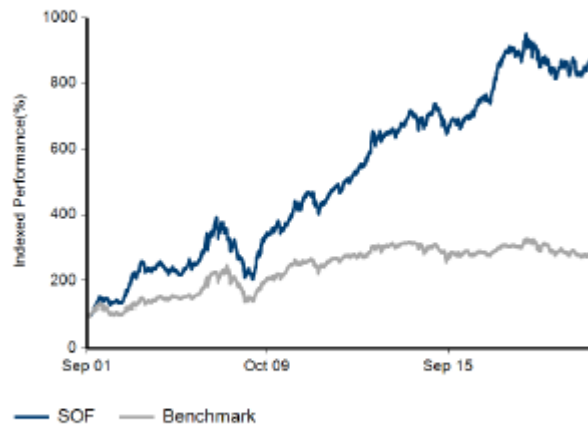
